Ex. of program violations include: unexcused absences from group, refusing a drug test, positive urinalysis, missing deadlines, curfew violation, unexcused school absences, inappropriate behavior, and any other violation of the Drug Court Contract.

- * Minimum amount of time for the Phase. Failure to complete Phase 1 in 120 days, Phase 2 in 90 days, Phase 3 in 60 days or Aftercare in 60 days may result in your discharge from the program.
- *Groups are held on Mondays, Wednesdays, and Fridays from 3:00pm-5:00pm or 5:30pm 7:30pm.
- *Parents must participate in their child's treatment process by attendance bimonthly at the Family Group Sessions at Aspire. Groups are held two Wednesdays out of the month from 6:00pm-7:00pm. Aspire will provide schedule.
- * Court is held every other Wednesday at 2:30 PM.
