**MISDEMEANOR/DUI PRETRIAL DIVERSION INFORMATION**

**Pretrial Diversion (PTD)** is a deferred prosecution program offered by the Office of the State Attorney and supervised by the Orange County Community Corrections Division. Successful completion of the Pretrial Diversion program will result in the dismissal of your case by the State Attorney.

**Program Eligibility:**

- Misdemeanor only
- Must be able to legally work and reside in the United States
- For DUIs
  - No prior alcohol-related driving offenses regardless of disposition
  - No dangerous driving patterns
  - No incidents involving crash/accident
- Approval by the Office of the State Attorney

**Standard Conditions:**

- Supervision length - Drug offenses, DV-partner related, and DUI Tier 1 cases (BAC < .15%): **12 months**  
DUI Tier 2 cases (BAC > .15%): **15 months**  
Other misdemeanors: **6 months**
- Community service - DUI cases - 50 hours; all other cases - 40 hours; unless specified by SAO
- Telephone Reporting fee \$6 - \$7 monthly, if applicable
- \$50 State Attorney fee
- \$50 monthly cost of supervision
- \$17 drug test fee
- \$20 intake fee
- Law Enforcement investigative costs, if applicable

**DUI Cases Tier 1 and Tier 2:**

DUI Level I School

Victim Impact Classes through MADD or Florida Safety Council

Substance abuse evaluation and any recommended treatment

Tier 1 = 10 day Vehicle Impoundment/Immobilization and a \$500 monetary contribution

Tier 2 = 6 month Ignition Interlock and a \$1000 monetary contribution

**Drug/Alcohol-Related Offenses:**

Substance abuse evaluation and any recommended treatment

Random observed urine screens

**Theft, Fraud and Property Cases:**

Impulse Control/Theft Prevention Class

**Carrying a Concealed Firearm:**

Class/program designed to educate on safety and the law regulating carrying a concealed firearm

**Battery Cases:**

Batterer's Intervention Program (Domestic Violence partner related)

Anger Management Class (minimum of eight hours in divided sessions for non-partner related cases)

No contact/no hostile contact with victim

**Sex-Related Offenses:**

Sex offender assessment and any recommended treatment

Sexually Transmitted Diseases (STD) awareness class

**Resisting Officer Without Violence Cases:**

Anger Management Class

Letter of apology

**Sale/Serve Alcohol to a Person Under 21 Years of Age:**

Class/program designed to educate regarding the law regulating selling alcohol to underage persons

**Special Conditions:**

In addition to the listed standard conditions, special conditions may be required based on the specific charge. Any special condition added will be provided at contract signing.

**Program Enrollment:**

- **Only the Office of the State Attorney can approve your case for Pretrial Diversion.**  
The Office of the State Attorney will forward a referral of your case to the Community Corrections Division, Pretrial Diversion Unit.
- If you are approved for the program, you will be signing a contract with the State Attorney office. You are not on the Pretrial Diversion program until the contract is signed by both you and the State Attorney.
- You will receive a letter with instructions to report for an intake appointment. **This could take a minimum of 12 weeks from your court date.**
- **You must keep all court dates** until the contract is signed by both you and the State Attorney.

- If you are on **Pretrial Release (PTR)**, you **MUST continue to make your phone calls** or see your PTR officer until you sign the contract for Pretrial Diversion.
